FERC Environmental Inspection – Notification of Corrective Actions

Dear Acting Secretary Reese:

On October 23, 2023, the Federal Energy Regulatory Commission (FERC or Commission) issued an Order Issuing Certificate (Order) in the above referenced docket authorizing WBI Energy Transmission, Inc. (WBI Energy) to construct, modify, operate, and maintain its Wahpeton Expansion Project (Project) in Cass and Richland Counties, North Dakota. On February 13, 2024, the Commission authorized WBI Energy to proceed with construction of all Project facilities.

On September 17 and September 18, 2024, the monthly FERC environmental inspection was conducted for the Project. During the inspection, the environmental inspector identified two problem areas and a non-compliance as further described in Attachment A. WBI Energy is hereby submitting its response to the Notification of Required Corrective Action or Response.

Attachment A includes a summary of the noncompliance, how it occurred, when it was corrected including photo documentation, and steps WBI Energy has implemented to ensure similar occurrences will be avoided. Also included in Attachment A is documentation that the two problem areas identified during the inspection have been corrected. WBI Energy has corrected the issues identified in the environmental inspection and is committed to ensuring similar issues do not re-occur.

WBI Energy will continue to implement the mitigation measures in FERC's *Upland Erosion Control, Revegetation, and Maintenance Plan*, and *Wetland and Waterbody Construction and Mitigation Procedures* to further reduce impacts during construction and restoration.

Non-Compliance

Date: 9-18-2024

Location: Mileposts (MP) 42.05 to 58.50.

Project-related materials not contained within approved workspace limits per Plan IV.A.

Description of Non-Compliance Occurrence:

Material sloughed off the top and sides of the segregated topsoil piles and rolled outside of approved workspace boundaries. In addition, during construction activities along the right-of-way, material was pushed outside of the approved workspace boundaries.

Corrective Actions:

Starting on September 19, 2024 at MP 58.50 and concluding on September 22, 2024 at MP 41.00, material found outside of the staked approved workspaces was either removed by hand or by equipment remaining within the approved construction right-of-way and placed within the staked approved workspaces.

On September 23, 2024, the environmental inspectors conducted refresher environmental training for all contract machinery operators and spotters. The training was delivered in English and Spanish languages.

Avoidance of Similar Occurrences:

Additional contract personnel have been deployed to monitor the construction right-of-way during earth moving activities and have been instructed to leave adequate space for sloughing of soil piles and/or moving of soil considering the soil conditions. The environmental inspectors will continue to routinely monitor the edges of approved workspace boundaries to ensure material is staying within the approved workspace boundaries. WBI Energy has also directed other third-party craft inspection to routinely monitor the edges of approved workspace boundaries to ensure material is staying within the approved workspace boundaries. These activities will be completed in accordance with the FERC's *Upland Erosion Control*, *Revegetation, and Maintenance Plan* (Plan) and *Wetland and Waterbody Construction and Mitigation Procedures* (Procedures).


